## Short Term Tender Notice


For and on behalf of the Governor of Jammu & Kashmir, sealed tenders containing financial and technical bids affixed with revenue stamp of rupees ten and accompanied with CDR amounting to Rs.25,000/- (Rupees Twenty Five Thousand Only) drawn from any nationalized/scheduled bank pledged to the Accounts Officer, Directorate of Information, J&K Government are hereby invited from principal manufacturers, authorized dealers, Channel Partner supplier for supply of following items mentioned below as per specification given:

### Broad terms and conditions of the NIT:

1. The tenders should reach the office of Director Information & Public Relations, J&K Government, Media Complex, Opposite Sher-i-Kashmir Park, Pologround, Srinagar, near Lenz Restaurant on 14-06-2019 or before till 4:00 pm. The tenders shall be opened on 17-06-2019 at 2.30 P.M or any other convenient date in the office chambers of Director Information & Public Relations (Chairman SLPC) in presence of tenderers or their authorized representatives who may wish to be present for the said purpose.
2. The tenderers shall quote the rates both in words and figures without any cuttings. The rates to be quoted should be inclusive of all the taxes. The rates should be FOR J&K and valid for the Financial Year 2019-20.
3. The tenders without CDR shall not be entertained and shall be rejected.
4. The tenderers should have after Sale/Service arrangement both at Srinagar and Jammu.
5. The tenderers shall also furnish, clearance certificate from the Commercial Tax Department and Income Tax Department for the last quarter of 2018-19.
6. The tenderers shall attach with the tender an attested copy of GST/CST Registration Certificate. The tenders should record the TIN Nos. on the face of the tender and also attach a copy of TIN Registration Certificate and other documents.
7. The tenderers shall furnish copies of catalogues, brochures and authorizations certificates from the principal companies/authorized dealer/channel partner.
8. The successful tenderer shall have to execute an agreement with the department for the successful completion of the contract before placement of orders.
9. In case, the successful tender fails to execute the supply order placed for, the CDR of the defaulter tenderer shall be forfeited and penalty as decided will be imposed.
