
Sir,

Please provide photocopy of the value statement monthwise of advertisement released to all empanelled new papers of Jammu and Kashmir divisions (News paperwise) in respect of daily/Bi-weekly/ Weekly/ fortnightly/ monthly/ National newspapers from 1.4.2019 to 30.06.2019 of Govt. Budgeting department and non-Budgeting department, mentioning the total number of pages of publication with colour or black & white of all categories of newspapers.
- ii. Please provide photocopy of the information whether all the empanelled newspapers published from Jammu and Kashmir divisions fall under Category 'D' or there is some other category framed by Empanelment Committee in the records of the Information Department both in colour and black and white (12 and 8 pages-dailies) and also please provide authenticate information if there is no category of empanelled newspapers categorized by the empanelment Committee on what method has been adopted by Information Department releases the Govt. advertisements to the empanelled newspapers without category.
- iii. Please provide photocopies of the all directions/message/letter, sent through mail of the department, mentioning the name of the daily newspaper, issued to Joint Director, Jammu and Kashmir divisions respectively by the Directorate of Information Department for publishing of coloured full page/half page advertisements in the


newspapers from time to time from 1.4.2019 to June 30, 2019 in respect of Jammu and Kashmir divisions.

- iv. Please provide the photocopies of value statements datewise and monthwise of all the newspapers published from Jammu and Kashmir divisions which are issued colour advertisements, full page/half page by Joint Director Information, Jammu and Kashmir divisions with effect from 1.4.2019 to 30.06.2019 from empanelled newspapers both budgeting and non-budgeting.
  - v. Provide photocopy of the budget allotment (Plan and Non-Plan) of both the divisions of the State allotted by Director Information for the year 2018-19 and 2019-20 on account of payment of Govt. advertisements and also provide the statement of expenditure incurred against the allotted budget.
  - vi. Please provide photocopy of the Budget allotted by Chief Electoral Officer to the Information Department for the year 2018-19 for settling the bills for election advertisements published in the empanelled newspapers. And also provide the expenditure incurred on this account in respect of both the divisions of J&K State i.e. Jammu and Kashmir. Also please provide information whether any budget has been allotted by Electoral Officer to the Information Department for the year 2019-20 for settling the bills on account of election advertisements.
1. I state that the information sought does not fall under the restrictions contained in section 8 and 9 of the Act and to the best of my knowledge it pertains to your Department. The information is required in the larger interest of the general public.
  2. A fee of Rs.10/- (Rupees Ten only) towards the application fee is deposited in the form of Indian Postal Order bearing No. 43 033693 dated 28.06.2019 in favour of the Accounts Officer in the o/o Director Information, Jammu and Kashmir, Polo View Srinagar.

I shall deposit the additional fee for inspection of the records, maintaining records of advertisement section/monthly files of the newspapers of the concerned above mentioned paras, under the purview of Section 5 (d) of the Act for which the information seeker be provided information about timing pertaining to the above mentioned paras. The information seeker shall be ready to get the information through Pen drive/CD which shall be provided by the information seeker himself. If available on website of the Department the applicant the information be provided accordingly through pen drive as provided under RTI Act.
  4. Further, I also undertake to pay additional fee/charges (if applicable) prescribed under Right to Information Act and/or relevant rules.
